COMMUNITY CHARGE CAPPING

You may like to be aware before Cabinet tomorrow of the latest position on the handling of decisions on community charge capping. (As far as I am aware Mr. Patten does not intend to raise the subject tomorrow, but you will recall that Mr. Ridley did raise it at Tuesday's Cabinet).

We had already made provision for two meetings of E(LG) next week, on Tuesday and Thursday. But from what I have seen of DOE's initial work it is clear that this is going to be a very difficult issue to resolve; the technicalities of any particular capping system are considerable, and the balance to be struck on the political considerations will be delicate.

Against that background I do not think it would be wise for the first chance you have to consider the DOE propositions to be in a full meeting of E(LG). It is far too big a committee.

So I suggest the following handling, which I have established that Chris Patten would be content with:

- you should have a first informal meeting just with Chris Patten and Norman Lamont (plus Cabinet Office and Policy Unit) next Monday. That meeting would consider some initial papers and material put together by DOE
- at the end of that Monday meeting you can decide

 whether or not you want a paper to be put that evening
 to E(LG) for a meeting of that Committee on Tuesday.

 The alternative would be to cancel E(LG) on Tuesday
 and to use that meeting slot for ministerial whether or not you want a paper to be put that evening ministerial group; either the same cast as on Monday or a slightly expanded group.

then go on to a full meeting of E(LG) on Thursday to seek endorsement of whatever package you have sorted out in the small ministerial group. We could reorganise Thursday morning's timings so that the E(LG) meeting came before Cabinet; if you wanted you could then have a formal report of the E(LG) outcome to Cabinet.
